ACKNOWLEDGEMENT, CONSENT AND RELEASE

1. The registrant above enrolls in the ski/board program at Otis Ridge, hereinafter referred to as owner, subject to the rules and regulations determined by the owner and its agents, including the program descriptions and policies included with the enrollment package.
2. The Registrant acknowledges the inherent danger and risk of personal injury involved in the enrollment and involvement in the activities of the owner and assumes any and all risk of personal injury in the enrollment and activities.
3. Massachusetts G>L>, ch 143, sec. 71P provides, with limited exceptions, that no action shall be maintained against the operator of this ski area for an injury to a skier unless the injured person shall, within ninety (90) days of the incident give the operator notice by registered mail of the name and address of the injured person and the time, place, and cause of the injury. Any action to recover for injury shall be brought within one (1) year of the date of injury.
4. The Registrant covenants not to sue and releases the owner, and any other sponsors or agents, from any liability arising out of personal injury wherein the injury was the result of an activity conducted as part of the usual activity of the owner. The owner assumes no responsibility for activities undertaken by the Registrant without proper supervision and guidance.
5. The Registrant acknowledges that the provisions of the Acknowledgement, Consent and Release shall be binding upon the Registrant, his heirs, executors, administrators and assigns, and shall be governed by the laws of the state of Massachusetts. The Registrant agrees that any suit or legal action shall be brought only in the state of Massachusetts and that terms of this document shall be admissible in evidence as a binding legal agreement between the Registrant and the owner. The Registrant acknowledges that if a Court determines that part of this document is inadmissible that the remaining paragraphs shall remain in full force and effect.
